FIELD NOTES OF 1.561 ACRES OF LAND

Being 1.561 acres of land situated in the James Davenport Survey, A-274, Cass County, Texas, and being part of the residue of that certain 80.134 acres tract of land described in deed from Notan R. Maxie and wife, Bobbie Jean Weens, Maxie, to Scotty Carroll Prince, recorded in Vol. 1049, Pg. 294, of the Real Property Records, Cass County, Texas (RPRCCT), and being the same tract of land (called 2 acres) described in deed to Vanderbilt Mortgage and Finance, Inc. recorded under Cass County Clerk's File No. (CCC) 2013000213, in the Official Public Records, Cass County, Texas, and being more particularly described as follows:

BEGINNING at a railroad spike found in the centerline of County Road 4448 (CR 4448) for the NW Corner of the Lane Stuwart Shepard 5.00 acres tract (Deed Reference: Vol. 1131, Pg. 590, RPRCCT, same being the northernmost NE Corner of the said residue tract and the NE Corner of this tract;

THENCE: S 02 deg 22' 40" W, with and along the west line of the said 8.000 acres tract, at 26.67 feet passing a capped (all caps in this description are imprinted "RPLS 4214) 1/2" steel rebar found for reference on the south side of CREATE, and continuing for a total distance of 208.63 feet, to a capped 1/2" steel rebar found for the SE Comer of this tract;

THENCE: S 53 deg 37' 15' W, across the said residue tract, 417.60 feet, to a capped 1/2' steel rebar found for the SW Corner of this tract;


THENCE: N 02 deg 22' 25" E, across the said residue tract, at 178.84 feet passing a capped 1/2" steel rebar found for reference, and confirming or a total distance of 208.96 feet, to a railroad spike found in the said centerline of CR 4448 for the NW Corner of this tract;

THENCE: N 53 deg 39' 26" E (bearing pasis per said CCC 2013000213), with and along the said centerline, 417.41 feet, to the POINT OF BEGINNING and containing 1.561 acres of land.


