

## Field Notes - 29.93 Acres

Situated about 16.4 miles North 44° West from the City of Linden, in the County of Cass, State of Texas, a part of the Thomas Williams Survey #1072 and being all of a called 29.938 acre tract conveyed to Vanderbilt Mortgage and Finance, Inc. by deed recorded in Document #2011002966 of the Official Public Records of said County and State.

Beginning at a 3/8" iron pin found at the intersection of County Road #2727 and County Road 2728 and being in the South boundary line of the J.Darnell Survey #285 and being the Northwest corner

Thence South 89°53'17" East along said County Road #2727 a distance of 1287.85' to a 5/8" iron pin found at the Northeast corner of the 29.938 acre tract and being the Northwest corner of a tract of land conveyed to Steve N. Womack by deed recorded in Vol. 1122, Page 282 or said Real Property Records;

Thence South 0°24'43" West passing a 3/8" iron pin found at a distance of 26.59' and continuing on along a fence for a total distance of 1045.26' to a cross tie fence corner post found at the Northeast corner of the residue of a called 72 acre tract conveyed to Rita Annette Zorn et al, by deed recorded in Document #2006002042 of said Official Public Records, said point being the Southeast corner of the 29.938 acre tract:

Thence North 89°51'58" West along a fence a distance of 1039 06' to a 1/2" capped iron pin found in the East boundary line of a called 2 1/2 acre tract conveyed to Arthur G. Womack and wife, Gail Womack by deed recorded in Vol. 428, Page 557 of the Deed Records of said County and State, said point being the Southerly Southwest corner of the 29.938 acre tract;

Thence North 1°35'59" East along a fence a distance of 170.15 to a 1/2" capped iron pin found at the Northeast corner of the 2 1/2 acre tract and an inside corner of the 29 938 acre tract;

Thence South 87°36'19" West along a fence and passing a 3/8" fron pin found at a distance of 207.31' and leaving said fence and continuing on for a total distance of 250.64' to a 1/2" iron pin found in County Road #2728;

Thence North 0°17'04" East along said County Road and along the East boundary line of a called 71 acre tract conveyed to Judy Womack Hicks and Jane Womack Leeves by deed recorded in Vol. 1106, Page 744 of said Real Property Records a distance of 885.72' to the point of beginning and containing
